Please put a copy of your Insurance papers in the Insurance Folder, next to the Hunting Sign-in book in the Clubhouse. Insurance can be purchased through New Jersey Federation of Sportsmen's Clubs, or the NRA.

Use of the Club Post—Swim Season

The Club may be used all year round by Club Members. In particular, the Pavilion is open for picnics and camping is allowed. Guest Fee is \$5 per person, out of the swim season. Please sign in on the logbook under the Pavilion. Please note: there may be people hunting in the CSC woods from Sept 13 thru May 22. Also, note that the outside bathrooms and kitchen are only open through the end of October.
